## SIDE LETTER OF AGREEMENT

### **BETWEEN**

#### THE CITY OF LAGUNA BEACH

AND

### THE LAGUNA BEACH POLICE AND FIRE MANAGEMENT ASSOCIATION - FIRE UNIT

This Side Letter of Agreement ("Agreement") between the City of Laguna Beach ("City") and the Laguna Beach Police and Fire Management Association ("LBPFMA") - Fire Unit is entered into with respect to the following:

**WHEREAS**, the parties are currently parties to a Memorandum of Understanding (MOU) with a term of July 1, 2021 through June 30, 2024; and

**WHEREAS**, the City has agreed to provide Juneteenth as a holiday for members of the LBPFMA starting in 2022; and

**WHEREAS**, the following sets forth the parties' Agreement:

1. The parties agree to amend Article 22 of their MOU as can be seen with the track changes below:

## 22.0 Holidays

- **22.1 Recognized Holidays:** The following holidays shall be observed by the City of Laguna Beach:
  - 1. New Year's Day January 1st
  - 2. Martin Luther King Jr. Day 3<sup>rd</sup> Monday in January
  - 3. President's Day 3rd Monday in February
  - 4. Memorial Day Last Monday in May
  - 5 Juneteenth June 19
  - 65. Independence Day July 4th
  - 76. Labor Day 1st Monday in September
  - 87. Veterans Day November 11th
  - 98. Thanksgiving Day 4th Thursday in November
  - 109. The day after Thanksgiving
  - 1<u>1</u>0. Christmas Day December 25th

Notwithstanding that the above are the holidays for employees in the unit, if the Fire Chief needs the employee to work on any of the above holidays, they will be required to do so.

**22.2 Compensation For Holidays:** Fire Division Chiefs and Fire Battalion Chiefs shall be paid 5.08 hours per pay period. <u>Effective the pay period beginning June 13, 2022, Fire Division Chiefs and Fire Battalion Chiefs shall be paid 5.58 hours per pay period.</u>
