#### **Recap of Minutes**

PRESENT: Commissioners: Donna Ballard, Suzi Chauvel, Michael Ervin, Laura Ford, Pat Kollenda, Adam Schwerner,

and Karen Wood.

STAFF: Sian Poeschl, Cultural Arts Manager; Michael McGregor, Arts Program Coordinator; and Jamie Bichler,

Public Art Coordinator.

1) Karen Wood called the meeting to order at 5:00 p.m.

- 2) Minutes of the September 12, 2022, meeting were approved as presented. M/S Kollenda/Schwerner. Commissioners Ballard and Wood abstained from voting due to previous absence.
- 3) Chair's Announcements: Karen Wood welcomed new Public Art Coordinator Jamie Bichler. The Artist Review Panel recently approved two applications for an artist occupancy permit. Ms. Wood commended the Sunset Serenades and Artist in Residence concerts.
- 4) Commissioner and Staff Communications: Commissioners Chauvel and Ervin commended the Artist in Residence concert on September 24, 2022. Commissioners Ervin, Kollenda, and Schwerner commended Pacific Opera Project's Sunset Serenades performance on September 23, 2022. Staff Poeschl introduced Public Art Coordinator Jamie Bichler. Staff Bichler greeted the Commission and introduced herself. Staff McGregor noted the success of the Artist in Residence and Sunset Serenades concerts and invited Commissioners to attend the season finale concert featuring Jason Feddy on September 30, 2022, at 5:30 p.m. at the Heisler Park. Staff McGregor noted the deadline of October 3, 2022, to submit designs for the Holiday Palette Competition. Staff McGregor noted the Juried Fine Art exhibition at City Hall was installed and open to the public through November 17, 2022, and invited the Commission to attend the artist reception and awards ceremony on November 3, 2022, at 6:00 p.m.
- 5) **Public Communications:** None.
- 6) Items for Discussion and Action:
- A) "Art and Nature" Temporary Art Installation Staff Poeschl described the "Art and Nature" program, noted the locations for the 2022 installations proposed by the Laguna Art Museum, and noted the reviews conducted by the City's Cultural Arts, Marine Safety, Police, Fire, and Community Development departments. Staff noted public safety concerns with possible headlight reflections at site at Main Beach Park, the Marine Safety recommendation to adjust artwork to avoid locations under a cliff, and concern for liability to the City with the site on the cliff at Monument Point. Staff noted the Museum would provide personnel to accompany each piece, the piece at Main Beach would be remain in place for the duration of the exhibition, and the other pieces would be installed daily during museum hours. Staff introduced Julie Perlin Lee, Executive Director of the Laguna Art Museum, and artist Kelly Berg.

Ms. Perlin Lee described the entire program and provided Kelly Berg's artistic background. Ms. Berg presented her proposed installations.

Pat Kollenda recommended the gazebo as a thematically fitting alternative to the site at Monument Point. Suzi Chauvel and Michael Ervin noted concerns about the demur scale of each piece. Adam Schwerner noted the issue of City liability with the installation at Monument Point with having to cross a safety handrail and retaining wall. Staff Poeschl noted the location of site at Monument Point conflicts with the artist's concept of the public being able to interact with and move around the work.

Mr. Schwerner asked if the Museum could provide an alternative site for installation at Monument Point. Ms. Perlin Lee affirmed it was possible, but suggested safety harnesses for the installers instead. Ms. Berg suggested an alternative site near Picnic Cove.

A motion was made to approve the proposed installations and sites except for the site at Monument Point and directed staff to obtain departmental approvals for an alternative site once provided by the Laguna Art Museum. M/S Kollenda/Schwerner. Yeas: Ballard, Chauvel, Ervin, Ford, Kollenda, Schwerner, Wood. Noes: None.

- B) Youth Art Advisory Board Staff McGregor described the Youth Art Advisory Board program and noted four applications were received. Staff Poeschl noted the Board would meet with subcommittees to provide input. A motion was made to appoint Ella Berberian, Emma Purdy, Ava Roop, and Agata Shamis to the Youth Art Advisory Board for the term of October 2022 through May 2023. M/S Schwerner/Kollenda. Yeas: Ballard, Chauvel, Ervin, Ford, Kollenda, Schwerner, Wood. Noes: None.
- C) Art That's Small at City Hall Staff McGregor presented the program guidelines, entry form, and dates for 2023 through 2025. A motion was made to approve the guidelines and dates through 2025 as presented. M/S Kollenda/Ervin. Yeas: Ballard, Chauvel, Ervin, Ford, Kollenda, Schwerner, Wood. Noes: None.

SUBJECT: 224 Forest Avenue (Bushard's Pharmacy) Temporary Mural Installation (Item 7A)

An application has been received from the proprietor and owner of Bushard's Pharmacy, located at 224 Forest Avenue to install a mural on an existing wall at the rear of their property facing Forest Lane. The mural, titled "Lovely Day" will measure 19.5' in height by 13.5' in width and be painted with acrylics. Due to the nature of the materials the mural would be considered a temporary installation for an exhibition period of up to five years or based on condition. This is consistent with a similar approval made by the Carts Commission for a mural on Glenneyre. In proximity to the proposed mural is a City owned mural, "Little Treasures", neither installation would affect viewing of the other.





Existing site conditions.

The Public Art Sub-Committee, consisting of Commissioners Donna Ballard, Suzi Chauvel and Adam Schwerner have reviewed the application and is recommending approval of the mural installation for an exhibition period of up to five years or based on condition, this exhibition period can be extended through a request of the Commission.

If approved, Staff will prepare a memorandum to the City Council and Planning Commission on behalf of the City Manager. Upon review, members of the City Council or Planning Commission have 10 days in which to appeal the Arts Commission decision. If appealed the application would be reviewed by the Planning Commission.

#### City of Laguna Beach Municipal Code

#### **Chapter 25.54 Sign Regulations**

"Mural" means an original work of art that is applied or attached to an exterior wall. (At the discretion of the arts commission a mural may be considered a wall sign, if it contains words, logos, trademarks or graphic representations of any person, product or service that identify a business.)

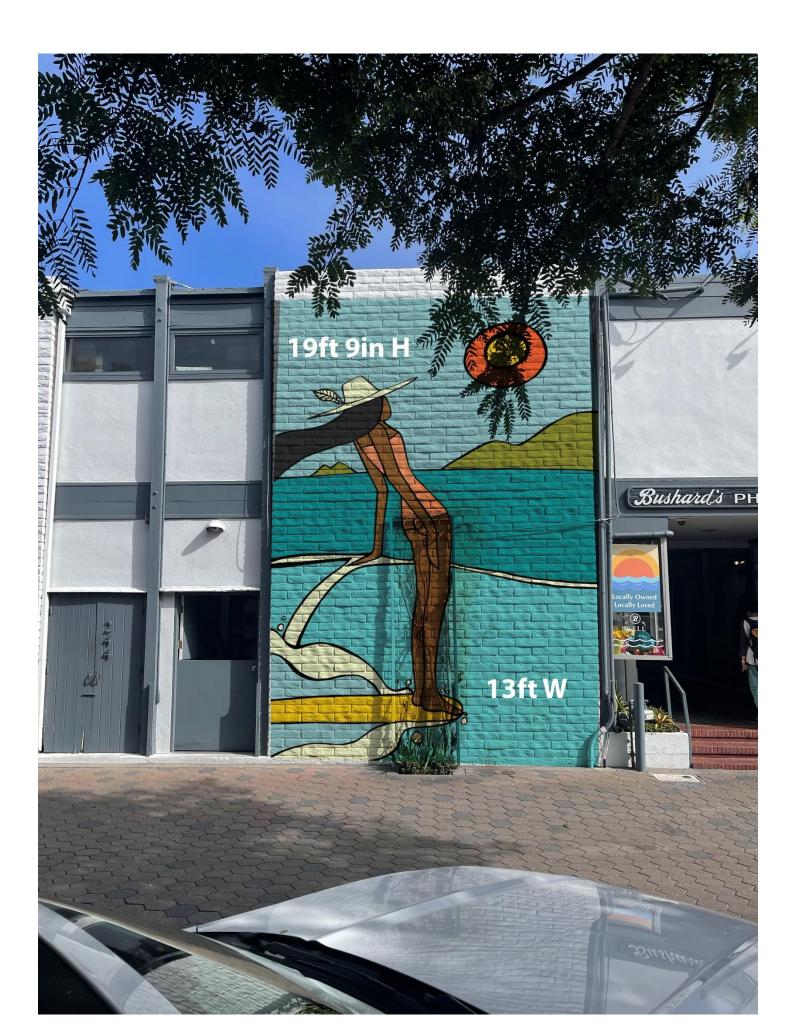
#### 25.54.024 Murals.

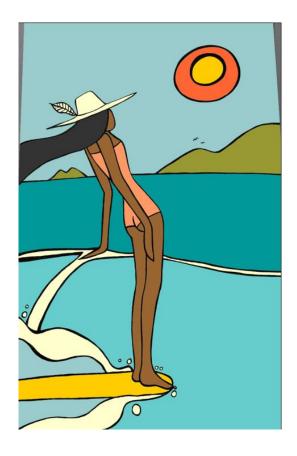
- (A) Murals shall conform to the design standards and permit procedures outlined below; except that murals proposed in compliance with Chapter 1.09 (Art in Public Places) shall be governed by the design standards and permit procedures of that chapter, and mural proposals which are considered to be wall signs shall conform to the design standards applicable to wall signs. Signature(s) of the artist(s) shall be allowed and limited to a maximum of two square feet.
- (B) The following procedures shall govern the approval of mural proposals:
  - (1) Applications. Applications for mural permits shall be submitted to the department of community development on an approved application form and shall be accompanied by the following: a site plan showing the lot and building dimensions and indicating the proposed location of the mural; a scale drawing and color photo of the building showing the proposed size and placement of the mural; a colored drawing of the proposed mural; and the proposed maintenance schedule.
  - (2) Arts Commission Review Required. The arts commission shall review and approve all proposed mural applications. If the proposed mural contains words, logos, trademarks or graphic representations of any person, product or service that identify a business, the arts commission shall determine whether the proposal is a mural or a wall sign.
  - (3) Heritage Committee Review Required. If a mural is proposed on a historic structure identified on the city's historic resources inventory and/or city's Historic Register, the heritage committee shall review and make a recommendation regarding the mural proposal prior to the review of the arts commission.
  - (4) Additional Review. All proposed murals located in the downtown may be appealed to the planning commission by a member of the planning commission or city council for review and approval.
  - (5) Criteria. In addition to the design criteria set forth in this chapter and Section 25.05.040 for design review, the following criteria shall be considered in the review of mural applications:
    - (a) Visual Enhancement. The proposed mural has attributes that enhance the site;
    - (b) Artistic Excellence. The proposed mural exemplifies high artistic quality of original artwork;
    - (c) Public Safety. The proposed mural does not create a public safety issue;
  - (6) Lighting. Proposed lighting of murals shall minimize glare and/or light spillage onto the public way or adjacent properties;
  - (7) Long-term Maintenance and Removal. The mural shall be maintained in good condition for the life of the mural according to the maintenance schedule and responsibilities approved by the arts commission. The removal or deaccession of murals shall comply with the deaccession policy established by the city council of Laguna Beach. (Ord. 1499 § 1, 2009; Ord. 1408 § 1 (Atth. A (part)), 2002).

#### Overview

The City of Laguna Beach's annual Banner Competition was established in 1982. The hand-painted banners are created by local artists and are displayed citywide from light poles during the summer season. The deadline to submit banner designs, which celebrate our summer season and our culture, is March 6, 2023.

#### Summary of the Matter

The competition guidelines have been updated for 2023 and reflect the scheduled dates for the competition. Arts Program Coordinator, Michael McGregor and Public Arts Coordinator, Jamie Bichler will work with the Banner Competition subcommittee to review submissions and make recommendations prior to the Arts Commission selection on March 13, 2023. The Arts Commission has budgeted for the selection of up to four (4) designs to be made into banners in addition to having previously approved the increase in the artist honorarium from \$3,000 to \$4,000.

It is recommended that the Arts Commission approve the guidelines as presented for 2023-2026 or revised as necessary.

# 2023 Banner Competition

#### Description

The City of Laguna Beach Banner Competition is a project of the Arts Commission. Artists are provided with banner material on which to paint original artwork. The completed banners are displayed on lampposts throughout the city of Laguna Beach during June, July and August and celebrate the summer season. The completed banners are temporary and will be displayed when and where the City desires for up to 7 years or based on condition.



#### Eligibility

Open to Orange County, CA residents, 18 years of age or older. Employees, Council members, Board members and Commissioners of the City of Laguna Beach are not eligible to apply.

#### **Application Requirements**

Artists may submit ONE design as part of the following required materials:

- A color design drawn to scale (4 x 16 inches)- Bright colors are suggested. Religious symbols are discouraged. The banner is painted on both sides; if your design is not a mirror image please submit the design for both front and back. **Do not sign your submitted design.** Designs should be hand drawn or painted.
- Professional resume (maximum 2 pages)
- 3 images of previous related artwork showing artists ability to complete large-scale work.
- Completed application form must be mounted to the back of the design.

**Title:** Red Telephone Booth Temporary Art Installation

**Location:** Forest Avenue, Downtown

#### Overview

The City of Laguna Beach Red Telephone Booth is a project of the Arts Commission. The K-6 telephone both is located on Forest Avenue in downtown Laguna Beach. The public telephone has been removed and the booth now serves as a location for temporary art installations selected via a call for artists juried by the Arts Commission. The purpose of the biennial competition is to add to the City's public art collection with high quality artwork.

#### Summary of the Matter

The current installation "Call to Action" by artist Jeffery Skarvan was installed in April of 2021 with a designated period of 24 months. The competition guidelines have been updated and reflect the scheduled dates for the upcoming competition.

#### Recommendation:

Staff recommends the artist honorarium be increased from \$5,000 to \$8,000. This reflects similar honorarium increases to programming such as the Banner Competition. This installation was not included in the approved budget for FYI 2022/2023 therefore will need approval from the Arts Commission to allocate the funds from the Special Programs Budget of the Laguna Beach Tourism Marketing District. In FYI 2021/2022 a carryover of \$8,000 in savings from the Cultural Arts Calendar is available. It is recommended that the Arts Commission approve the schedule, artist honorarium, funding, and guidelines as presented.

#### **Eligibility**

Open to artists who are residents of Imperial, Los Angeles, Orange, Riverside, San Bernardino, Santa Barbara, San Diego, and Ventura counties. Employees, Council members, Board members and Commissioners of the City of Laguna Beach are not eligible to apply.

#### Honorarium

\$8,000

#### **Location Description**

The K-6 telephone booth is located on Forest Avenue near various commercial and retail spaces in downtown Laguna Beach. In 1935, architect Sir Giles Gilbert Scott created the telephone box which is an iconic image throughout the United Kingdom. Called K-6, the design was commissioned by the Post Office to commemorate the silver jubilee of King George V. Royal though its patronage may be, the telephone kiosk made technology available to everyone. Although once used as a telephone kiosk, the public telephone has been removed and the box is now serves as an installation site for temporary public art.

#### **Project Description**

The proposed proposal and design should be imaginative, whimsical, and colorful. Artist may incorporate a design or installation on the interior or exterior of the box. The box measurers 3' x 3' x 8'4" and is permanently affixed to the sidewalk. The proposed artwork will be owned by the artist and, if designed for that purpose, returned to the artist at the conclusion of the exhibition period. Please note, there is no electricity available, so any lighting proposed must be solar.

#### **Materials**

Materials should be durable, safe, and appropriate to a public setting. The installation will be for a period of 24 months.

#### Laguna Beach Public Art Program

The City of Laguna Beach Red Telephone Booth is a project of the Arts Commission. The purpose of the biennial competition is to add to the City's public art collection with high quality artwork. It is the primary responsibility of the City of Laguna Beach Arts Commission to preserve and protect the collections under its management for the people of the City of Laguna Beach. Deaccessioning is the process by which the Arts Commission recommends to the City Council that an object be removed from the City's collection. The City shall deaccess works of art in its collection only in the

public interest and as a means of improving the quality of its collections. The selected design will be subject to City Council approval.

#### **Selection Process**

The seven members of the City of Laguna Beach Arts Commission will judge the entries. Judging of the winning design will be based on creativity and appropriateness for the location.

The City of Laguna Beach Arts Commission reserves the right, as its interest may appear, to reject any and/or all applications or proposals, to reject any finalist, to waive informalities in applications or proposals, or to terminate the selection process for any project without prior notice. The Arts Commission reserves the right to make selections for this project from the Arts Directory if insufficient applications are received, or to terminate the project at any time. Application to any project advertised by the City of Laguna Beach Arts Commission constitutes agreement with all applicable rules and guidelines.

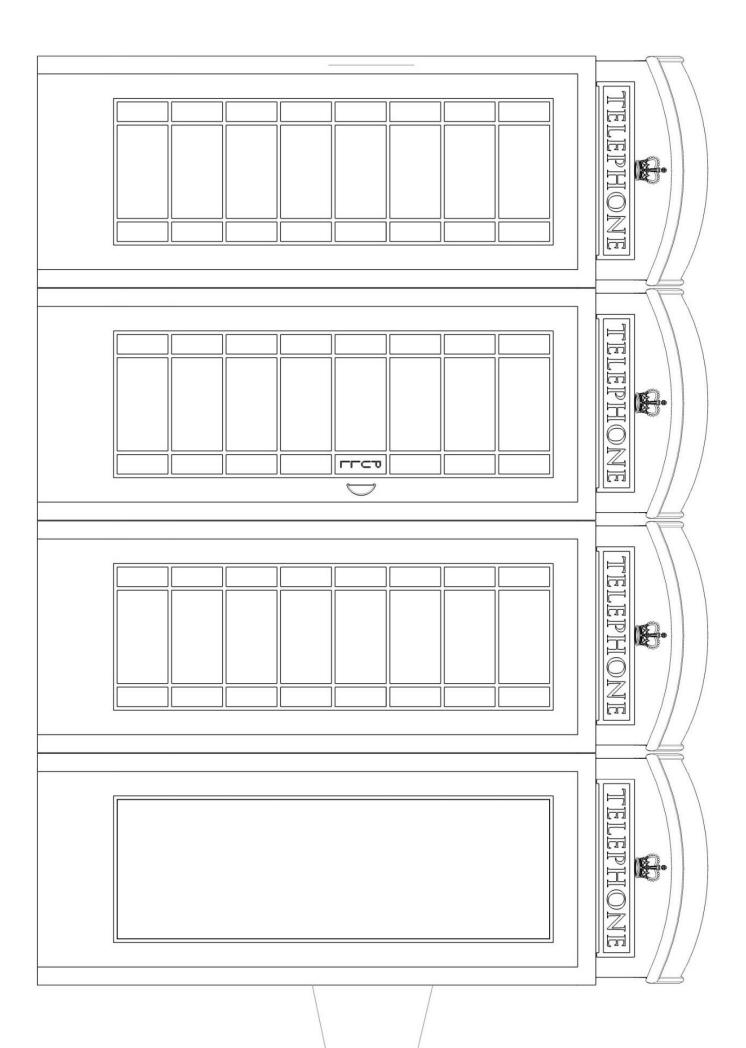

Title: Holiday Palette Competition

**Location:** Laguna Beach, CA

#### Overview

The Holiday Palette Competition is open to artists who reside, work, or exhibit in Laguna Beach and are 18 years and older. The painted original artworks adorn lampposts throughout the city during the winter holiday season. Design submissions for the competition were received until 5:30 p.m. on October 3, 2022. The Arts Commission has the materials and budget for the selection of up to four (4) designs. Completed palette designs become property of the City of Laguna Beach and are displayed when and where the City desires for up to 7 years or based on its condition.

#### Summary of the Matter

The sub-committee has reviewed the submitted palette designs and may provide an oral recommendation. The Arts Commission will review the submitted designs and may select up to four (4) winning designs to be turned into full-scale 3' x 4' palettes. Selected works should be high quality, original designs. The Commission may decide not to select any submissions.

# Supporting the Arts in Laguna Beach

Deadline: Monday, February 6, 2023.

**Edibility:** Non-profit organizations with the primary purpose and experience in presenting arts programs in Laguna Beach. Collaborative programming will be accepted, with the organization whose primary focus in presenting the arts being the lead applicant.

**Goal:** The purpose of this funding is to create quality cultural art experiences that benefit guests that stay overnight at Laguna Beach hotels while improving the experience for residents. The funds available support art projects that promote tourism and related events.

- In 2018, the City of Laguna Beach approved a Creative Placemaking Assessment which identified cultural art activation sites. Organizations are encouraged to utilize sites within the Civic Arts District for its programming including, but not limited to: Festival of Arts and Sawdust Art Festival. Additional sites include Main Beach Cobblestones, Laguna Art Museum, Laguna Playhouse and the Promenade on Forest, creative site solutions such as no traditional venues will be considered.
- Funds for this grant are made available through the Laguna Beach Tourism Marketing District. The funds are dedicated for grants to organizations wishing to enhance the cultural arts environment of Laguna Beach and related programming. The grants are operated and reviewed by the City of Laguna Beach Arts Commission and approved by the City Council.

The City of Laguna Beach is committed to work with cultural arts organizations to ensure the development and success of a vibrant arts community. Applicants are encouraged to provide expanded programming that deepen and expand active experiences in the arts.

In evaluating applications, consideration will be given to the following:

- 1. Non-profit organizations with functioning arts programs.
- 2. Cultural arts programs that provide the greatest benefits in meeting the needs of Laguna Beach, its residents, and visitors.
- 3. New/ and or expanded art services not currently being provided.

**Title:** 2023 Mini Banner Competition **Location:** City Hall, 505 Forest Avenue

#### Overview

The City of Laguna Beach's annual Banner Competition was established in 1982. The hand-painted banners are created by local artists and are displayed citywide from light poles during the summer season. In addition to the full-scale 16' x 4' banners, smaller 4' x 2' banners are displayed from the light poles directly outside City Hall. The current small-scale banners in the collection were created by artists Kiki Davis and Max Presneill in 1998 and are showing significant wear.

#### Summary of the Matter

The competition guidelines reflect the scheduled dates for the competition which will run simultaneously to the normal Banner Competition. Cultural Arts staff will work with the Banner Competition subcommittee to review submissions and make recommendations prior to the Arts Commission selection on March 13, 2023.

The Arts Commission currently has \$22,000 in savings carried over from its Special Programs Budget, originally designated for the Professional Speaker Series.

#### Recommendation:

It is recommended that the Arts Commission approve the guidelines as presented and approve expenses and honorariums for the "Mini-Banner Competition" be allocated from the Special Programs Budget.

Description

The City of Laguna Beach Mini-Banner Competition is a project of the Arts Commission. Selected artists are provided with banner material, measuring 4 ft. x 2 ft., on which to paint original artwork. The mini-banners are displayed on lampposts in front of Laguna Beach City Hall June, July and August and celebrate the summer season. The completed banners are temporary and may be displayed when and where the City desires for up to 7 years or based on condition.

#### Eligibility

Open to Orange County, CA residents, 18 years of age or older. Employees, Council members, Board members and Commissioners of the City of Laguna Beach are not eligible to apply.

#### **Application Requirements**

Artists may submit ONE design as part of the following required materials:

- A color design drawn to 1:6 scale (4" x 8" inches)- Bright colors are suggested. Religious symbols are discouraged. The banner is painted on both sides; if your design is not a mirror image, please submit the design for both front and back. **Do not sign your submitted design.** Final banners will be hand painted by the selected artists, so submitted designs should be hand drawn or painted.
- Professional resume (maximum 2 pages)
- 3 images of previous related artwork showing artists ability to complete large-scale work.
- Completed application form must be mounted to the back of the design.

March 6, 2023 Prospective designs and application materials must be delivered by 5:30 p.m. to:
