Title: 2023 City Hall Exhibition Schedule

#### Overview

The City of Laguna Beach Cultural Arts Department utilizes the first-floor hallways of City Hall as a year-round exhibition space for local arts organizations and City-sponsored competitions. City Hall has been host to successful exhibitions by Laguna College of Art & Design, The Artist Fund at the Festival of Arts, Community Art Project, Laguna Plein Air Painters Association, and the Festival of Arts Permanent Collection in addition to the City's annual Juried Fine Art, Art That's Small and Children's Holiday Palette competitions. These exhibitions serve to enhance the interior space of City Hall with high-quality art from local artists and arts organizations as well as engage members of the community to show support for the arts and local government.

City staff coordinates with organizations to install and remove exhibitions during hours that City Hall is closed to the public. Title: World AIDS Day

**Location:** Downtown Laguna Beach

#### Overview

The international recognition of World AIDS Day takes place on December 1, each year to show support for people living with HIV, and to remember those who have died from an AIDS-related illness. In recognition of this day, the Cultural Arts team and Arts Commission recognize this day by displaying black and red ribbons on sculptures in the downtown area. In addition, information cards are placed with the ribbons to identify the significance of World AIDS day and the displayed ribbons.

#### Recommendation:

Title: Temporary Public Art Installation
Location: City Hall, Laguna Beach, CA

#### Overview

The Arts Commission has facilitated several successful temporary installations outside City Hall and staff has been working with the Public Art Sub-Committee to facilitate programming for 2023. The subcommittee and staff are recommending an installation titled "Polymery" by Taylor Dean Harrison. (Artist)

"Polymery" (meaning the characteristic of having many parts) consists of two sculptures which stand at 15' height each with a footprint of 10'. The sculptures are created of steel and contain a digital light system that casts light patterns in a 60' diameter circle. Staff will work with the Artist to ensure the light does not extend beyond the City Hall lawn. During daylight the dichroic glass within the sculpture will reflect sunlight. The sculptures will be anchored into the grass with steel mounts. The works reflect the philosophy of the Artist of engaging the viewer to explore the light patterns and movement.

Taylor Dean Harrison's artworks have toured festivals and fairs internationally, he has exhibited in galleries and museums, and features in private collections. He attended art school at UC Berkley and is based in Oakland California and is originally from San Clemente.

#### Summary of the Matter

The sculptures are available in February for a three-month exhibit at a rental cost \$25,000 this includes, rental, artist fee, installation, de-installation, anchoring, management, and maintenance. There is currently a fund balance of \$57,441.80 budgeted for temporary art installations in FY 2022/2023 Arts Commission Special Programs budget of the Laguna Beach Tourism Marketing District.


#### Recommendation:

Title: Relocation of Artist Designed Bench Location: 237 Ocean Ave, Laguna Beach, CA

#### Overview:

The Arts Commission facilitated and funded the Installation of the artist designed bench titled "Streamline" by Larry Gill and Gavin Heath located on the first block of Ocean Avenue. The bench was installed in 2012, with an honorarium of \$10,000 and installed on an existing sidewalk with adequate surrounding space.

During COVID, and to support restaurants, the City approved several parkettes for outside dining. The Community Development Department approved a parklet outside 237 Ocean (The Warf.) The parkette design has limited public access and altered the aesthetics of the work. Initially it was unsure how long parkettes would remain, however the California Governor has approved their use through 2023 and may be extended. The Artists and public have noted their concerns about the condition and access to the work which can be seen in Attachment A.

Staff has worked with the Artists, Public Works, and Community Development Departments to relocate the bench to an alternative location in the Downtown. A location at the corner of Ocean Avenue and Beach Street was identified, replacing an existing City bench, and is included as Attachment B. The location will provide visibility on both front and back of bench as well as adequate light to pass through the glass featured on the backrest of the bench. The new location will still allow for clear viewing of the existing sculpture "The Shopper."


The first phase of this relocation involves removing the bench from its current location and undertaking restoration and repairs which include replacing the metal understructure, cleaning, and sealing the concrete and polishing the stainless steel. The bench has not required any restoration or maintenance since its installation. It is anticipated that this phase will cost \$5,000. The second phase will involve an application for an Administrative Design Review in addition to new footings and machinery to relocate the bench once restores at a cost not to exceed \$5,000.

#### Recommendation:

Staff recommends: 1) approval to relocate the bench "Streamline" as described in this report; 2) approve a budget of up to \$5,000 to restore and repair the bench; and 3) approve a budget not to exceed \$5,000 for site preparations and associated miscellaneous costs funded from the Arts Commission Special Programs budget of the Laguna Beach Tourism Marketing District.
