A. Existing policy for offseason use of the Festival of Arts grounds (including the Irvine Bowl, Fine Art Exhibit are and Forum Theatre. (Festival of Arts)

David Perry reviewed the policy for offseason use of the Festival of Arts (Festival) grounds which is utilized by non-profits for special events and fundraising in addition to use by their sublessor Terra Laguna. Mr. Perry remarked on the difficulty in balancing the uses while maintaining the grounds and that the Festival had invested \$18 million to renovate the facility. The Festival has accepted applications from non-profit organizations for events in 2023, and that facility rental rates do not cover the costs incurred. Mr. Perry noted the Irvine Bowl Policy Committee determines the policies and costs.

Christine Georgantas, Exhibits Director at the Festival reviewed the calendar and administrative protocol of booking and that most offseason events occurred September through November with no demand for the Irvine Bowl. Ms. Georgantas noted that sound equipment was provided by each event, and that rental did not include audio equipment, however the levels were monitored.

Council Member Blake suggested the Festival increase its rates and that if organizations could not afford the rates, it was not the right venue for them.

Public Communications: Thirteen residents spoke about increased noise levels from the Festival grounds during the offseason. Maria Inez Frase, Edward Kaufman, Georgina Connolly, Karen Redding, Joseph Hakimpour, Kyle Palmer, David Masimo, Nancy Birkhauser, Sharon Johnso, and Lesly Scherer. requested solutions to the acoustics, decrease in off-season events on the grounds and at Terra Laguna.

Summary Sheet - FOA Proposed & Current Rental Fee Schedule 2023

Pricing Summary

- 1. The goal of the increased fee schedule is to cover costs for the Festival of Arts when renting the grounds to Laguna Beach nonprofit organizations. Although it does not address the costs of wear and tear on the facility, the proposed fees would cover the basic 2023 costs.
- 2. Proposed rates include power washing and event insurance (currently paid for separately by nonprofits)
- 3. Admin fees of \$400-800 per event that are included in current costs have been removed in proposed pricing.
- 4. Current rates are all daily rates. Proposed rates are per event (up to 3 days).



If using FOA employees for **Overnight Security, you are required to have 2 guards from 12-8am. This rule does not apply if you are hiring an independent security vendor.


Festival of Arts Events Sound Policy

- 1. Sound will be monitored by the Festival of Arts/Pageant of the Masters (FOA/POM) throughout events with amplified sound. Amplified sound is defined as any sound made louder through a device (e.g. speakers, drums, bullhorns, sound systems).
- Sound equipment will be set up in a way to maximize guests' enjoyment and minimize sound migration outside the event location. Sound level shall not exceed 70 decibels at the "Neighborhood Sound Boundary." See diagram below.
- 3. Applicant will identify a single point of contact from their organization to be notified in the case the sound needs to be turned down.
- 4. Applicant will comply with the FOA/POM Sound Policy during their entire rental period.
- 5. No amplified sound is permitted at the Festival of Arts or Terra Laguna Beach before 9AM OR after 10PM (Friday, Saturday, Sunday) and 9PM (Monday-Thursday); with the exception of the Pageant of the Masters performances. and Irvine Bowl Policy Committee approved catering events by Terra, which shall not use any amplified sound after 11:00PM.
- 6. Live Auctions must conclude by 8pm.
- 7. Violations of the Festival of Arts sound policy may result in future applications event approvals being denied. Violations are defined as exceeding the 70 decibel limit at the "Neighborhood Sound Boundary" for a cumulative 15 minutes during an event, using amplified sound after 10pm, or live auctions not concluding by 8pm.

SOUND POLICY

- Sound will be monitored by the Festival of Arts/Pageant of the Masters (FOA/POM) throughout events with amplified sound.
- Amplifiers will be set up in a way to maximize event guest enjoyment and minimize sound migration outside
 the event location. Sound level shall not exceed 85 decibels at the "Neighborhood Sound Boundary."
 See diagram below.
- Applicant will identify a contact from their organization to be notified in the case the sound needs to be turned down.
- 4. Applicant will comply with all sound recommendations from FOA/POM before, during, and after the event.
- No amplified sound is permitted on the FOA/POM grounds before 9AM or after 10PM; with the exception
 of the Pageant of the Masters performance and Irvine Bowl Policy Committee approved catering events by
 Terra, which shall not use any amplified sound after 11:00PM.
- 6. If the Applicant violates the FOA/POM sound policy, the FOA/POM, at its discretion, may deny future applications by the organization to rent any portion of the FOA/POM grounds.





Objective

FOA consistently receives complaints about sound levels from the surrounding neighborhoods. A remote monitoring system allows FOA to be in control of the decibel (dBA) level in accordance with City Municipal Code 7.25 NOISE, while keeping good faith with our community partners.

A permanent solution to noise issues, monitoring online could be available to both FOA and to law enforcement, the city, and the neighborhood. This would prevent unnecessary use of city resources and complaints.

Proposal

A proposal to install NTI Noise
Monitoring System to address
concerns about noise levels in the
surrounding neighborhood. Featuring
a remote monitoring system and post
processing software, the Festival of Arts
(FOA) would be able to monitor sound
levels year-round, for both in-house and
rental events.

We are proposing three (3) sound monitoring sites; one at the end of the Olive St. path at the back of the Irvine Bowl, and two others at a tobe-determined site on the Festival grounds in proximity to the Stage & Green.





Our monitoring spots were determined with the assistance of Sage Technologies' technical specialist, based upon the acoustic flow and common problem areas.

These two systems should allow for proper monitoring of noise on both sides of FOA grounds. The system recommended is NoiseScout, an NTI Noise Monitoring System that allows for remote monitoring.

Laguna Beach Noise Level Standards

Laguna Beach Municipal Code 7.25 NOISE lays out the requirements for allowable exterior noise in the designated noise zone IV, Civic Arts District.

Exterior noise standards as laid out in MC 7.25.040 are at 70 dBA at the property's sound border.

Factors and standards that may be considered when evaluating if a violation has occurred include: the ambient noise level, the time of day and night the noise occurs, the duration of the noise, and the density of inhabitation of the area within which the noise emanates

As required by the city, FOA's speakers are directed, to the extent feasible, toward open unoccupied space and is controlled so that it will not be unreasonably loud (MC 7.25.120).

Laguna Beach Noise Level Measurement Requirements

Laguna Beach Municipal Code 7.25 NOISE lays out the requirements for allowable noise level measurement systems.

When measuring noise levels at a nonresidential location shall be the closet point on the affected property to the noise source. The measurement microphone height shall be five feet above finish elevation (MC 7.25.150).

Decibel measurements made shall be measured with a sound level meter using the A-weighted sound pressure level. The A-weighted filter de-emphasizes the very low and very high frequency component of sound in a manner similar to the response of the human ear.

A noise (sound) level meter must meet the International Electrotechnical Commission (IEC) 60651 and 60804 Standards, for Type 1 sound level meters. This includes an output meter and frequency weighting network (MC 7.25.020).

Sage Technologies


Several noise monitoring service providers were contacted. Out of these providers, Sage Technologies proved to have the best system (NoiseScout) to ensure proper noise monitoring and reporting.

Sage Technologies specializes in sound and vibration testing, and was suggested by NTI. They both sell and can install the systems needed.

Our contact is Evro T. Wee Sit, a Technical Specialist who has worked on Sofi Stadium and other comparable venues. An expert in acoustics and measurements, he recommended the NoiseScout system to meet our needs.

System Recommendation

Sage Technologies recommends the state-of-the-art NTI Audio system NoiseScout. Used by venues like the Sofi Stadium in Los Angeles and the Orange County Fair Grounds, this system complies with the requirements laid out in MC 7.25.




Outdoor stations may be placed strategically throughout the Festival and Pageant grounds. **These stations will monitor sound levels and alert users when decibel levels exceed the allowable exterior noise level** in the Civic Arts District, which is 70 dBA (MC 7.25.040).

The weatherproof enclosures are tailored fixed installation solutions for unattended noise monitoring. The enclosures are highly secure and constructed of strong, hard-wearing materials.





System Features



NOISE SCOUT

Direct access to the XL2 Sound Level Meter is available around the world. The internet connection allows SFTP (Secure File Transfer Protocol) and remote access to the XL2. This offers the freedom to start and stop the online noise monitoring from your office or your mobile device.

The XL2 Sound Level Meter is configured remotely. The NoiseScout monitoring solution reports compliance violations and data connection irregularities by email. Audio recordings of the periods with the highest sound level, as well as the ability to listen to live audio, assists with the identification of causes of noise.





The XL View displays noise levels in large size in your preferred web brows. Levels are presented with a pre-warning amber or alarming red color in case preset limits are exceeded. A view-only link may be forwarded to stake holders for their online monitoring.

City of Laguna Beach Municipal Code

7.25.040 Exterior noise standards.

(A) The following exterior noise standards, unless otherwise specifically indicated, shall apply to all properties within a designated noise zone.

⁽¹⁾ If the ambient noise level exceeds the resulting standard, the ambient noise level shall be the standard.

- (B) It is unlawful for any person at any location within the incorporated area of the city to create noise, or to allow the creation of any noise on property owned, leased, occupied or otherwise controlled by such person, which causes the noise level when measured on any other property, to exceed either of the following:
 - The noise standard for the applicable zone for any fifteen-minute period;
- (2) A maximum instantaneous (single instance) noise level equal to the value of the noise standard plus twenty dBA for any period of time (measured using A-weighted slow response).
- (C) In the event the ambient noise level exceeds the noise standard, the maximum allowable noise level under such category shall be increased to reflect the maximum ambient noise level.
- (D) The noise zone III standard shall apply to that portion of residential property falling within one hundred feet of a commercial property or use, if the noise originates from that commercial property or use.
- (E) If the measurement location is on a boundary between two different noise zones, the lower noise level standard applicable to the noise zone shall apply. (Ord. 1448 § 1, 2005).

⁽²⁾ Measurements for compliance are made on the affected property. (See Section 7.25.150 for details.)
