#### Overview

The Laguna Beach County Water District (LBCWD) building located at 306 Third Street is being proposed as the site for a Temporary Public Art Mural. The project is being developed by the Laguna Beach Garden Club represented by Karen Nelson in collaboration with the LBCWD represented by Assistant General Manager Christopher J. Regan and artist Matt Wiley.

#### **Summary of the Matter**

Currently there is a twenty-five-foot wide and six-foot-high blank wall adjacent to the entry vehicle gate at the LBCWD located in the downtown with an existing planter in front of it titled the Bruce Scherer Waterwise and Fire Safe Demonstration Garden. This proposal includes plans for a twenty-five-foot wide and six-foot-high bee themed mural on that wall.

Artist Matt Wiley is a designer and mural painter with nearly thirty years of experience painting murals for private and public clients. He is also the Founder and President of The Good of the Hive project, "a global project igniting curiosity and conservation through art and bees". As seen in the examples included in this Application, the Artist is creating murals and installations around the world in an effort to raise awareness of the importance of pollination while highlighting the beauty and power in human connection. The proposed mural artwork for LBCWD is titled "The Good of the Hive" and is designed as illustrated herein. The installation process will include power washing and patching of the wall, with an application of a Behr Latex Primer, and artwork applied with Chroma Mural and Modern Masters Paints. The mural will be sealed with Exterior Dead Flat Varnish.

The proposal also includes a refurbishing and re-planting of the planter with water-wise plants with drip irrigation, and a refreshening of the surrounding landscape, including adding a walkway of hexagon shaped cement pavers in sand allowing the public easy access to photograph the mural. The planter will be made of eighty hexagon pavers to mimic a beehive, with twelve engraved stones interspersed.

There will be an aluminum sign affixed to a large rock held in place with cement that will hold a plaque identifying the artist and the Laguna Beach Garden Club. There will be three QR codes for more information: the artist's Hive Foundation QR Code, The Water District's QR Code, and the Laguna Beach Garden Club's QR Code which will reiterate the importance of pollinators.

The Consent letter from LBCWD confirms their intent to maintain the mural. The artwork will become an extension of the District's Bruce Scherer Waterwise and Fire Safe Demonstration Garden. Time and resources necessary to maintain the mural will be provided by the Water District.

LBCWD, working with the artist, will also provide the appropriate lighting to spotlight the artwork as identified in the Lighting/Irrigation Plan notes, including a thirty-watt equivalent low voltage integrated LED black outdoor landscape path light, five hundred and fifty lumens, and a LED spotlight twenty-watt equivalent black integrated LED, two hundred lumens.

All required documentation for this application has been received.

#### Recommendation

The Art Commission Public Art Sub-Committee consisting of Adam Schwerner, Pat Kollenda and Donna Ballard have reviewed the submission and will give a verbal recommendation at the meeting.

Staff recommends the temporary mural be approved for one year, as indicated in the approved Public Art Ordinance and Policy document and be administratively extended upon annual review in collaboration with the LBCWD and the Laguna Beach Garden Club based on the condition of the mural with no additional applications or permits.

#### Application: Artist's Statement

This mural in Laguna Beach in partnership with the Laguna Beach Garden Club and the Laguna Beach Water District is part of a global art project generating radical curiosity, connection and change – one pollinator at a time.

Artist Matt Willey is creating murals and installations around the world in an effort to show what one tiny bee showed him back in 2008 - We are all more connected than we realize, and amazing things happen when we start acting like it.

Water, like food and pollination, is an example of something that must be viewed as shared. A bee sees all that comes into the hive as collective and water is as important to their health as nectar. Without water, the hive cannot produce honey or maintain the temperature needed for survival. In the way a bee is both an individual and a part of superorganism called a hive, water is both within us and the basis for all life and health on earth.

Through color, line and beauty this mural is meant to remind people that water is not just essential to physical life for humans, it is one of the things that can remind us of our profound connectedness to each other.

Healing the planet is a marathon, not a sprint. Eight years into an estimated 21-year project, Willey has created 48 murals and installations with over 10,000 hand-painted bees. He has reached hundreds of thousands of people and created large-scale works at the Smithsonian's National Zoo in Washington DC, Dag Hammarskjold Plaza, NYC, and Burt's Bees Global Headquarters. He has collaborated with the World Council of Peoples for the United Nations (WCPUN) and NYC Parks' Art in the Parks Public Art Program. He has painted in a Tony-Winning Broadway star's dressing room in NYC, at a fire station in the American south and at schools across the country and in the UK. October of 2021 through August 2022 his bees were displayed at the American Embassy in Beijing, China.

Matt has shared the stories of The Good of the Hive through speaking engagements at the United Nations, the FAO in Washington DC, the German and French Embassies in DC, Burt's Bees Global HQ, Smithsonian's National Zoo, Duke University, MIT, Georgetown University, Auburn University, the Planetary Health Alliance 2018 annual meeting in Scotland, many podcasts including the NEA and educational institutions throughout the US.

His work has been featured in the *New York Times*, Reuters London, The Today Show, *The Huffington Post, The Washington Post*, and countless other publications and media channels.

A feature documentary about his work is currently in production.

SUBJECT: Artist Innovation Grants (Item B)

On August 14, 2023, the Arts Commission approved the guidelines for Artist Innovation Grants recognizing and supporting artists who reside, exhibit or work in Laguna Beach. The grant is intended to support artists who push the boundaries of creative expression, anchor our community, and advance the creative field. The approved budget allocated allows for the distribution of \$50,000 from the Arts Commission Special Programs budget of the Laguna Beach Marketing and Tourism District. The full guidelines and selection process review are attached.

The Commission has received 19 applications which have been reviewed by the sub-committee consisting of Chair, Donna Ballard, Vice-Chair Adam Schwerner and Treasurer, Michael Ervin. The applications can be reviewed HERE.

The sub-committee found consensus in supporting two applications, Monica Prado (\$10,000) and Andrew Corradini (\$20,000) there was also support from two members of the proposal by Hedy Buzan (\$10,000) As noted in the guidelines the Arts Commission may select one or multiple proposals and reserves the right to reject all proposals.

It is recommended that the Arts Commission hear the comments and discussion of the sub-committee and approve grant allocations not to exceed \$50,000.



# CALL FOR ARTISTS ARTISTIC INNOVATION GRANTS FOR ARTISTS

# Creating, Exploring and Implementing New Ideas

The City Council and Arts Commission recognizes and supports artists who push the boundaries of creative expression, anchor our Laguna Beach community, and advance the creative field. The Artistic Innovation Grants for Artists encourages the spirit of experimentation and exploration, exclusively engaging artists in Laguna Beach.

This grant program offers grants between \$5,000 and \$20,000 to support the art-making process and premiere of these endeavors. This program has been made possible through the generous support of the lodging establishments and City of Laguna Beach.

An Artistic Innovation Grant for Artists project is one that has in-person experiences of art, art making, or artists at the heart of the initiative and introduces a new or original idea or product to the applicants audience. Engagement through feature presentation and outreach included but is not limited to performance, publication, lecture/demonstration, exhibition, masterclass and/or workshop. Project proposals are encouraged to explore artistic excellence that goes beyond technical proficiency, that involves pushing boundaries, challenging conventions and produces work that resonates with audiences on intellectual, emotional, and aesthetic levels with a strong creative vision.

Applications will be accepted through October 9, 2023 for projects occurring between January 1, 2024 and December 30, 2025. Awards will be reviewed by the Arts Commission on November 13, 2023 and awards announced November 15, 2023. (Dates are tentative and may be subject to change.) Each applicant may submit one application and request an amount of \$5,000, \$10,000 or \$20,000. At the conclusion of the program grant recipients will be required to provide an overview of expenditures and brief description of the project undertaken.

These grants aim to support artists holistically to build a more equitable Laguna Beach Arts ecosystem. By pushing the boundaries of creativity and expression Artists contribute to the evolution of culture and human understanding.

#### DEADLINE: October 9, 2023

**ELIGIBILITY:** Artist who reside, work, or exhibit in Laguna Beach may submit <u>one proposal</u> Applicants must be 18 years and older by the application due date. Proof of eligibility will be required. Demonstrate through a professional resume at least three years of engagement in a creative practice prior to the application due date. **Conflict of Interest:** *City of Laguna Beach employees, members of City Boards or Commissions are in-eligible for this program.*

#### **SELECTION PROCESS:**

The Arts Commission will review the applications and make their selection based on the following:

- Qualifications: Artist qualifications as demonstrated by past work and the appropriateness of their concepts to the project. Of highest priority are the artistic capabilities of the artist and the inherent quality of their original artwork to enhance the City's cultural profile as demonstrated in the resume.
- <u>Artistic Excellence</u>: Artists and the proposal shall demonstrate excellence of creative and aesthetic ideas, a mastery of skills and techniques in the creation of original art works, communication of unique vision or perspective, and professional approaches to process and presentation. The Arts Commission will apply aesthetic and artistic judgements in their review.
- Public Liability: Safety conditions or factors that may bear on public liability.
- **Diversity:** Diversity of style, scale, media, and artists.
- <u>Content:</u> Appropriateness and relevance and should not contradict the City's values of environmental sustainability, accessibility, and cultural inclusiveness.

The Arts Commission may select one or multiple proposals and reserves the right to reject all proposals.

Applications are first reviewed by the Arts Commissions Sub-Committee. If the proposal is approved by the subcommittee the item will be placed on the agenda for the full Arts Commission. The Arts Commission will meet on November 13, 2023 to review the recommendations at 5 p.m. in the City Council Chamber, 505 Forest Avenue, Laguna Beach. (Dates are tentative and may be subject to change.)

The City of Laguna Beach does not provide any additional resources to the grant honorarium, and does not provide marketing, publicity, venue rental or reservation. The selected recipient will enter a contract with the City of Laguna Beach to undertake the project. Artists must keep the Cultural Arts Department updated on progress and identify the funding as the "Innovation Grants for Artists funded by the lodging establishments and City of Laguna Beach".

Title: 2023 Annual Review of City Banners for Maintenance and/or Deaccession

Location: City hall, 505 forest Avenue

#### Overview

The City of Laguna Beach cultural Arts Banner Program was established in 1982. Of the municipal collection, sixty to seventy banners are displayed annually over the summer season. At the end of each summer the City Public Works Department takes down the banners and cleans them. They are pressure washed, setting aside any that require repair or have been damaged beyond repair. Those that need repair and are within the seven-year life expectancy for a banner are offered back to artists to repair if they so choose. Those damaged beyond repair are de-accessed, utilizing the city approved procedure. After cleaning and sorting, banners ready to go back into storage are wrapped in plastic and returned to the city storage bay at Act V.

#### **Summary of the Matter**

Upon request, the Public works team put aside banners that have too much damage to be installed next season. Staff and Arts Commission Sub-Committee, Pat Kollenda, Carl Smith and Suzi Chauvel have reviewed the damage to the six banners.

#### **Recommendation:**

The sub-committee recommendation is to offer four banners for repair to artists, one with a two-hundred-dollar stipend, and to de-access two banners that cannot be repaired:

#### **Description**

The City of Laguna Beach Arts Commission is seeking 2D artwork to use in promotional materials for its Sunset Serenades music series. Sunset Serenades concerts are held at the Heisler Park Amphitheater each May and September featuring a variety of genres including original singer/songwriters, opera, classical, and jazz/blues, and a focus on world cultural music each June.

The proposed designs should be imaginative, colorful and include the theme of the Sunset Serenades concert program and/or iconic Heisler Park. The proposed design should convey a positive reference to Laguna Beach. Submitted designs must be at least 8 inches wide by 10 inches tall. The selected design will be

featured on concert schedules as well as online promotional content for the series. Concert schedule text and information will be laid over the design.

Designs may be hand-drawn/painted or digital 2D artwork. Photography will not be considered.

The seven members of the City of Laguna Beach Arts Commission will judge the entries. Judging of the winning design will be based on creativity and appropriateness for the location.

The Arts Commission reserves the right to make selections for this project from the Arts Directory if insufficient applications are received, or to terminate the project at any time. Application to any project advertised by the City of Laguna Beach Arts Commission constitutes agreement with all applicable rules and guidelines.
