Title: Premiere of "An Artist Perspective: Outdoor Banners"

Overview

The Cultural Arts Department currently has a video available on the City website focused on an overview of the City Public Art Collection. The intent of the video is to celebrate the artists and the collection and to make the community aware of these public art installations available to be viewed and enjoyed by all. In the past year, Cultural Arts Staff has endeavored to expand this informational media resource with the addition of another video, this one focused on the City Outdoor Banner program.

Summary of the Matter

The banner video has been created to de-mystify the process of creating an outdoor banner and encourage artists to apply for this opportunity. Funded from the general banner budget approved by the Arts Commission and collaborating with staff, Rick Graves was hired to film, direct and edit the five-minute video. It features veteran banner artist and painter, Al Esquerra, and Arts Commissioner Suzi Chauvel as they share in the details of the process and "best practice" tips for long-lasting outdoor banners. It will be added to the City website in February, 2024.

Title: Call for Artists – Temporary Public Art Installation

Location: Stage at the Promenade on Forest

Overview

In 2020, Forest Avenue was transformed into a pedestrian promenade with outdoor dining and entertainment. This area, in the heart of the Downtown is a retail area with numerous restaurants and boutique businesses located near Main Beach. The stage located on the Promenade is utilized for live music performances on Friday, Saturday, and Sunday evenings and was utilized as a space for a temporary mural. The current mural by artist Ryan Castillo at the Stage on Forest was installed in September 2022 and is scheduled for removal.

The Youth Art Advisory Board serves as youth ambassadors to the City's Arts Commission. One of the responsibilities of the Youth Art Advisory Board is to advise on programming during their seven-month appointment. The Board is proposing a temporary installation utilizing the stage area.

Summary of the Matter

The Youth Arts Advisory Board has convened with direction from City staff and drafted a "Call for Artists" for a temporary art installation or mural to occupy the Stage on Forest for up to one year. The theme was designated as "Marine Sanctuary" to advocate for sea-life conservation and acknowledge Laguna Beach as a marine wildlife sanctuary. Youth Art Advisors also recommended proposals to include the use of repurposed and/or recycled materials. The guidelines note the selected installation may remain for up to one year but will be determined by the materials used.

Recommendation

It is recommended that the Arts Commission take the following actions: 1) Hear the presentation of the Youth Art Advisory Board presented by Staff, 2) Approve materials to be used; 3) Recommend the duration of the installation; 4) Approve the theme of the call for artists; 5) Allocate a budget not to exceed \$5,000 from savings in the Arts Commission Special Programs Budget to fund the honorarium; and 6) Approve the guidelines as presented or amended.

CALL FOR ARTISTS

Stage on Forest Temporary Installation – Marine Sanctuary



DESCRIPTION

The City of Laguna Beach Arts Commission is seeking an artist to create a temporary sculpture installation or mural to be installed at the Stage on Forest, located at the corner of Forest Avenue and Glenneyre Street. The design should celebrate and include references to sea-life conservation and Laguna Beach being a marine sanctuary. It is highly encouraged that the proposed installation makes use of recycled and/or repurposed materials.

The stage is utilized for live music on Friday, Saturday, and Sunday evenings and must remain accessible to performances. Proposed installations should not block the store-front window. Murals would be expected to be painted on plywood sheets off-site, transported in, and fastened to the stage deck.

Installations must be durable, safe to the public, and withstand unprotected displays. Work must be appropriate in content for a public setting and audiences of all ages. The selected artist would be required to enter into a contract with the City of Laguna Beach, have liability insurance naming the City as additionally insured for installation and removal.

ELIGIBILITY

Open to Orange County, CA residents, 18 years of age or older. Employees, Council members, Board members and Commissioners of the City of Laguna Beach are not eligible to apply.

COMPENSATION / AWARD

The selected artist will be awarded a \$5,000 honorarium. The completed temporary installation may be displayed for up to one year or based on condition.

APPLICATION REQUIREMENTS


Artists may submit ONE design as part of the following required materials:

- Professional resume (maximum 2 pages)
- A color design or rendering- The proposed design should be bold, graphic with bright colors and the design should be engaging when the stage is not in use.
- Proof of residence (photo ID, utility bill, etc.)
- Expected duration of the installation.
- Description of materials, installation method, and how the design fits the theme.
- 3 examples of previous related artwork showing artists ability to complete large-scale work.

JURYING PROCESS

The seven members of the City of Laguna Beach Arts Commission, with input from the Youth Art Advisory Board, will review designs anonymously for creativity and visual impact. The Arts Commission may select one or multiple proposals and reserves the right to reject all proposals.
