Title: 2024 Banner Competition

Overview

The City of Laguna Beach's Outdoor Banner Competition is a project of the Arts Commission. Selected artists are provided with banner material on which to paint original artwork. The completed banners become the property of the City of Laguna Beach and will be displayed on lampposts throughout the city of Laguna Beach during June, July, and August to celebrate the summer season. The completed banners are temporary and will be displayed when and where the City desires for up to 7 years or based on condition. Submissions were accepted through March 4, 2024. Completed banners will be awarded a \$4,000 honorarium. Completed banners must be returned to City Hall by May 2, 2024. The competition was open to Orange County, CA residents, 18 years of age or older.

Summary of the Matter

The Arts Commission Sub-Committee, Pat Kollenda, Carl Smith and Suzi Chauvel have reviewed the forty-one (41) submissions anonymously for creativity and visual impact. The Arts Commission has budgeted for the selection of up to four (4) designs to be made into banners.

SUBJECT: Public Art Activations (Item B)

The purpose of public art activations is multifaceted, and some key purposes are bringing vibrancy to a space transforming ordinary locations into engaging stimulating environments. Public art activations often include interactive elements or opportunities for community participation. These engagements can foster social connections, spark dialogue, and encourage people to explore and interact with public art in new ways.

The Cultural Arts Department is exploring the program starting with the temporary sculpture installation "Dream Big" currently on the lawn outside City Hall. Staff is recommending the following programming:

- Pop-Up Dog training "Learn to Stay" a 10-minute event on a Saturday morning culminating with a pup photo.
- Pop-Up Downward Dog Yoga is a 10-minute yoga class to learn the pose on April 24 and May 22, 2024.
- Social Media Invite all dog lovers to share photos of their pups using the hashtag #DreamBigLaguna.
- Pop-Up Newspaper collection by Protecting Unwanted Pets (PUP) for the Laguna Beach Animal Shelter
- Collaboration with the Police Department and Animal Services for a pet adoption video.

Staff are also exploring possible activations for the mural "Superbloom" by Dabsmyla at Alta Laguna Park in addition to future temporary installations.

It is recommended by Staff that the Arts Commission approve undertaking activations for temporary public art. The Commission in its 2024-25 budget has allocated \$10,000 to the program. Staff recommends the Arts Commission approve a budget not to exceed \$2,500 for the duration of March through June 30, 2024 for activation programming from Savings in the Arts Commission Special Programs budget. Costs would include payment to instructors, advertising the events and video capture.

Title: World Art Day

Overview

World Art Day is an international celebration of the fine arts which was declared by the International Association of Art (IAA) to promote awareness of creative activity worldwide. The date was decided in honor of the birthday of Leonardo da Vinci. Da Vinci was chosen as a symbol of world peace, freedom of expression, tolerance, brotherhood, and multiculturalism as well as art's importance to other fields. In 2022, the City Council made a proclamation recognizing April 15 as World Art Day.

Recommendation:

In recognition of this day, Cultural Arts staff is recommending displaying gold ribbons with informational cards on the public art installations in the downtown area on Monday, April 15, 2024.

Informational card:

Each year, World Art Day celebrations help reinforce the links between artistic creations and society, encourage awareness of the diversity of artistic expressions and highlight the contribution of artists to sustainable development. The City of Laguna Beach recognizes and celebrates all who participate and

Staff also recommends the creation of a 24" x 62" pop-up banner, at a cost not to exceed \$150 from savings in the Arts Commission Special Programs budget, to be displayed in front of City Hall.
