Title: Sawdust Art Festival Temporary Mural

Location: Rear entrance of the Sawdust Art Festival, 935 Laguna Canyon Road

Overview

The Sawdust Art Festival, located on Laguna Canyon Road within the Civic Arts District is proposing a Temporary Public Art Mural. The proposed mural, titled "The Space Between Land and Sea," will be located at the rear entrance of the Sawdust Art Festival on the existing perimeter fence.

The purpose of the mural is to create a visual space where viewers can interact and experience the surreal feeling of Laguna Beach and to echo the magic and lush abundance of the area. The Sawdust Art Festival exhibitor and artist, Kate Cleaves, was inspired by the unique energy of Laguna Beach and the colors of the sea and sky, as well as the organic flowing shapes of the flora and fauna. The mural aims to capture the beauty and harmony of the natural world and inspire viewers to live more sustainably and in sync with their surroundings.

The mural will be painted onsite in May 2024 on a perimeter fence that measures 8 feet in height and 50 feet in length. The mural will be a temporary installation and will remain on exhibit for twelve months, through May 2025. The estimated cost for the project is \$3,000, which includes the artist stipend which is funded by the Sawdust Art Festival who will also be responsible for its maintenance.

The mural will have an anti-graffiti sealant to protect the completed mural from graffiti vandalism. It acts as a barrier that makes it easier to remove graffiti without damaging the underlying paint or surface. The sealant creates a protective layer that can be cleaned or wiped off, allowing for easier maintenance and preservation of the mural's original appearance.

Recommendation:

The Public Art Sub-Committee consisting of Commissioners Adam Schwerner, Donna Ballard and Pat Kollenda are recommending approval of the twelve-month temporary mural by artist Kate Cleaves on the exterior of the Sawdust Art Festival.

Growing up in a small seaside town in Maine, Kate Cleaves spent her days painting, creating, and dreaming of a future home in a magical artist community, somewhere where her colorful whimsical works would fit in so well with the community that she would be able to follow her passions and be able to pursue a career as a full time artist.

Kate received her BFA in painting from the Maine College of Art and shortly after headed for the colorful coast of California. She landed in San Francisco and although her eight years spent in that city definitely helped shape the person she is now – it wasn't until visiting Laguna Beach in 2018 for the first time, where she walked into the Sawdust Art Festival, and she knew she had found her home... the place she had been dreaming of all those years.

She now spends her days painting, making fairies, illustrating children's books, and dreaming up murals in her 1930's beach cottage turned home studio. 

LIGHTING

Two fluorescent LED photocell lights will be mounted above the mural to provide sensored lighting when day transitions to night. Proposed lighting shall minimize glare and light spillage onto Frontage Road. Lighting will have a timer activated so that lights will turn off every night during after hours.

SURFACE MATERIALS

Latex paint, acrylic paint and sealant.

CONSTRUCTION MATERIALS

The perimeter fence will be prepped with half inch or quarter inch ACX plywood sheeting with minimal cuts and caulked seaming to ensure an ideal, smooth canvas for paint application.

PEDESTRIAN MITIGATION PLAN

The mural will be painted adjacent to a sidewalk onsite, over a 3 week period from May 2024 to June 2024. The mural will be completed two weeks before Sawdust Preview Night which occurs on June 25, 2024. The sidewalk itself will be protected with tarps and/or drop cloths, and pedestrians will be temporarily diverted around the artist's work zone by foot traffic delineators.

PROTECTANT

The completed mural will be finalized with a coat of anti-graffiti sealant.

MAINTENANCE

The Sawdust Festival Corporation will monitor and be held responsible for maintaining the mural.

Title: Promenade of Forest Temporary Installation – Presentation by finalists

Location: 295 Forest Avenue, Laguna Beach

Overview

The Stage on Forest is located at the corner of Forest Avenue and Glenneyre Street, a retail area with numerous restaurants and boutique businesses located near Main Beach. The stage is utilized for live music performances on Friday, Saturday, and Sunday evenings. The City issued a call for artists to design a temporary art installation or mural with the theme of "Marine Sanctuary" to occupy the Stage on Forest for up to three months or based on condition, with an honorarium of \$5,000.

Summary of the Matter

The Arts Commission reviewed artist submissions on April 8, 2024, and selected proposals by Brooks Atwood, Sara Dehghan, and Amy Rose Hammond as finalists. The selected artists were invited to present their proposals in person along with material samples and address concerns of the Arts Commission. Commissioners should consider the following aspects of each proposal:

- Originality of the proposed artwork.
- Provide material example durability.
- Installation method and how/where it will be affixed to the stage surface.
- Additional requirements including electrical needs, automated timers, etc.

Recommendation

It is recommended the Arts Commission hear the presentations of the three selected finalists and select a proposal for installation or deny all proposals and conclude the opportunity. If selected the installation would be on temporary exhibition from June through September 2024.




Examples of interactive LED floors (indoor/outdoor) showing fish swimming and the water moving/rippling.

SUBJECT: 2024 Music in the Park Performers (Agenda Item C)

The Music in the Park concert series is organized by the Arts Commission and Cultural Arts Department and is funded by the Laguna Beach Tourism Marketing District. The season runs from early July through August for seven consecutive Sundays with a diverse lineup of musical acts.

The selection process for performers in the Music in the Park concert series is rigorous and designed to ensure a variety of genres and styles are represented. The process involves the sub-committee of the Arts Commission and Cultural Arts Department staff.

Key criteria for selecting performers include:

- Musical quality and talent
- Diversity of musical genres to appeal to a broad audience.
- Local and regional representation to showcase talent from the community.
- Ability to provide an engaging live performance suitable for an outdoor setting.

Performers for the 2024 season are:

July 7, 2024 - The Great North Special The Great North Special

This Laguna Beach band was a recipient of an "Artist Innovation Grant" to produce an album. At the concert they will feature their original album. The seven-member band performs a blend of psych-rock, country, blues, and funk-soul originals and covers.

July 14, 2024 – Tabu TABU Videos | Tabu (thetabuband.com)

This Orange County Latin cover band consists of six performers with a male and female singer. The band showcases classics while injecting their own creative twist.

July 21, 2024 – The Shagwells <u>Videos/Mick Adams and The Shagwells, Soundtract of the Sixties</u>

This Arizona based five-member band brings back the soundtrack of the 60's and 70's and performs iconic hits of the Beatles, Rolling Stones, The Animals, The Who, to name a few.

July 28, 2024 – Upstream VIDEO | upstream (upstreammusic.com)

Upstream are seasoned performers who share their message of love and positivity through their Caribbean music, namely Reggae, Calypso, Soca, and Steel Drum. Lead singer Haile Blackman is originally from the Republic of Trinidad and Tobago and son of the legendary creator of Soca music, the late Ras Shorty. Also, from Trinidad and Tobago is the well-respected steel drum performer Derek Brewstafari.

August 4, 2024 – **133 Band 133 Band - Sep 11, 2023 (youtube.com)**

This all-star band features eight musicians, eight songwriters and five lead singers all from Laguna Beach. Brought together by Laguna Beach resident Clay Berryhill they are described as the greatest band that never was and feature Nick Hernandez, Poul Petersen, Beth and Steve Wood, Jason Feddy, Richard Bredice, Alan Deremo, and Frank Cotinola.

August 11, 2024 – Betamaxx BETAMAXX | Live VideosSan Diego's '80s Band (betamaxxband.com)

This 1980's cover band delivers a non-stop, nostalgia filled rock concert featuring the works of Michael Jackson, Madona to New Order and Depeche Mode. This seven-member band includes both male and female performers and are sure to pack the dance floor.

August 18, 2024 – The Tina Turner Tribute featuring Debby Holiday The Tina Turner Tribute by Debby Holiday - Video Not an impersonation act, the Tina Turner Tribute by vocalist Debby Holiday brings together 10 top touring musicians and the timeless music of Tina Turner. Debby Holiday was born and raised in Los Angeles, from a musical family, her father writing hits like "Put a Little Love in Your Heart" and has toured with Rod Stewart, KISS, Joe Walsh, and Lita Ford.

The Music in the Park series continues to be a highlight of the summer season, providing the community with high-quality musical entertainment in the beautiful outdoor setting of Bluebird Park and promises to be an entertaining season.

Overview

On February 26, 2024, the Arts Commission reviewed the recommended performers for the May and June 2024 Sunset Serenades concert series, as well as the proposal to add a performance by Pacific Symphony on October 4, 2024, to the fall concert series. Commissioner Kollenda moved the recommended actions, which were: 1) Approve the performers for the May and June concerts; 2) Approve partnering with Pacific Symphony to present a "Symphony on the Go!" concert on October 4, 2024; 3) Allocate \$1,000 from savings in the Arts Commission Special Programs budget to fund audio services for the "Symphony on the Go!" concert.

The minutes of the meeting were approved by the Arts Commission on March 11, 2024, but did not include the approval of the Pacific Symphony concert or its funding.

Summary of the Matter

The minutes have been revised to include the approval of a concert performance by Pacific Symphony on October 4, 2024, at a cost of \$1,000, funded through savings in the Arts Commission's Special Programs budget.

Title: Holiday Palette On-line Application Process

Location: 505 Forest

Overview

The Holiday Palette Competition is open to artists who reside, work, or exhibit in Laguna Beach and are eighteen years and older. The painted original artworks adorn lampposts throughout the City during the winter holiday season. The palettes are considered temporary art due to the nature of the materials used, displaying an average life span of seven to ten years. Typically, Public Works hangs approximately sixty palettes per holiday season.

Summary of the Matter

To improve the artist submission experience and assure timely accessibility to all Arts Commissioners for review, an upgrade from the current in-person or email application process is proposed to that of utilizing SlideRoom for digital applications. The artists can submit their entire application directly, in a unified format, including an image of their proposed design, understanding selected designs by the Arts Commission will be painted by hand. Currently most submissions are submitted via email or in person and prove awkward to share with the Banner and Palette sub-committee and at the Art Commission meeting. With SlideRoom, members of the sub-committee and all Art Commissioners can review the designs and other relevant materials submitted by an applicant directly. If approved, staff will continue to review each submission for eligibility and indicate any that do not meet required criteria.

Recommendation

It is recommended by Staff that the Arts Commission approve a submission modification for entries to the competition via an online application process.

2024 Holiday Palette Competition

Description

The City of Laguna Beach Holiday Palette Competition is a project of the Arts Commission. Winning artists are provided with a 4 ft. x 3 ft. wood palette on which to paint original artwork. The completed palettes are temporary and displayed on lampposts throughout the city during the winter holiday season when and where the City desires for up to 7 years or based on its condition.

Honorarium

Selected artists who return their completed palettes will be awarded \$700.

Eliaibility

Entries will be accepted from artists who live, work, or exhibit in Laguna Beach and are 18 years of age or older (proof required).

Submission Requirements

Applicants must submit a color design within the border of a palette outline (provided on page 3) to https://lagunabeachcity.slideroom.com/. The design must have a horizontal orientation with the palette indent on the top-left side as integral to your design. Please note that if your design is selected you may be required to reverse the indent and your design. Each applicant may submit one (1) design. Designs must be hand drawn or painted. Digitally generated imagery will not be considered.

If your design is selected, you will be provided with a 4' x 3' wooden palette with a primed surface ready to paint. You will be required to <u>paint</u> your approved design on one side with oil, acrylic, or other material that can withstand outdoor exposure. Remember that palettes will be viewed from a distance. There are no restrictions on the subject matter; however, religious symbols are discouraged.

Dates and deadlines

October 7, 2024 Prospective palette design and application must be submitted via

October 14, 2024 Arts Commission will review and select winning designs.

October 15, 2024 Artists will be notified of selection.

October 21-22, 2024 Selected artists to collect blank palettes from the Cultural Art Department.

November 18, 2024 Completed palettes must be returned by 10 a.m.

Selection

The seven members of the City of Laguna Beach Arts Commission will judge the designs based on creativity and appropriateness. The City of Laguna Beach Arts Commission reserves the right, as its interests may appear, to reject any or all applications or proposals, to reject any finalist, to waive informalities in applications or proposals, or to terminate the selection process for any project without prior notice. Application to any project advertised by the City of Laguna Beach Arts Commission constitutes agreement with all applicable rules and guidelines.

Acquisition, Display, Deaccession, and Removal from Collection

The completed palette and design become the property of the City of Laguna Beach and will be **displayed when and where the City desires for up to 7 years or based on its condition**. It is the primary responsibility of the City of Laguna Beach Arts Commission to preserve and protect the collections under its management for the people of the City of Laguna Beach. Deaccessioning is the process by which the City of Laguna Beach Arts Commission recommends to the City Council that an object be removed from the City's collection. The Arts Commission shall deaccession or dispose at will palettes in its collection only in the public interest and as a means of improving the quality of its collections.
