Eligibility: All who reside within the Laguna Beach Unified School District boundaries are eligible. Proof of residency is required at time of registration. Minors will need the signature of a parent/guardian.

Waiting Period: Begins on Saturday, June 1, 2024 at 7:00am. If surf is not adequate that weekend, the event is automatically postponed to the next weekend, if necessary.
Fridays will now be included in the waiting period. Split weekends are a possibility, if necessary (i.e. the contest begins on one weekend for one day and ends on another weekend day). Enter at your own risk!
