- 1) Donna Ballard called the meeting to order at 5:00 p.m.
- 2) The minutes of the May 13, 2024 Regular Meeting we approved as presented. M/S: Kollenda/Ervin
- 3) **Chair's Announcements:** Donna Ballard invited the public to the temporary public art dedication of "Attempted Murder" by Jack Champion on Friday, July 12, 2024, at 4 p.m. on the lawn of City Hall.
- 4) Commissioner and Staff Communications: Carl Smith and Staff Wood commented on the recent Music in the Park. Staff McGregor commented on the Music in the Park concert on July 7, 2024, noting strong attendance. He added that on July 14. 2024 the Latin-music band TABU will be performing. Staff Poeschl noted the Artist Review Panel will meet on July 25, 2024. She stated an item is on the City Council's Agenda on July 9, 2024, regarding the introduction and first reading of an ordinance amending the Municipal Code to streamline Artist Occupancy Permit applications and determine the Ordinance to be CEQA exempt. Staff Poeschl introduced temporary Administrative Assistant Elizabeth Fraijo to the Commission.
- 5) **Public Communications:** Resident Jorg Dubin suggested the addition of a mural be installed on the arched concrete wall areas of the parking structure located on Glenneyre Street.
- 6) Items for Discussion and Action:
 - A. <u>Election of Officers</u> The Commission discussed the election of Commissioners to serve a one-year term as Chair, Vice Chair, and Treasurer. A motion was made that the Commissioners remain in their respective offices for another year, namely: Chair Donna Ballard, Vice-Chair Adam Schwerner, and Treasurer Michael Ervin. Motion: Ervin. Second: Kollenda. Yeas: Ballard, Chauvel, Ervin, Kollenda, Schwerner, Smith. Noes: None.
 - B. Art in Public Places 1555 South Coast Highway Staff Wood presented an application for a new public art installation titled "Bombora" by Jorg Dubin to be installed at 1555 South Coast Highway to satisfy the Art in Public Places requirement for the property renovation. The sculpture will replace the defunct fountain by artist DeWain Valentine. Staff Wood and artist Jorg Dubin provided details on the new art piece and the installation process. Commissioner Schwerner raised concerns that the artwork could possibly be scratched by small loose rocks surrounding the artwork. It was determined no stones will surround the artwork, which will be bolted down to a permanent foundation. A motion was made to recommend that

the City Council approve the installation "Bombora" by Jorg Dubin to satisfy the Art in Public Places requirement for the renovation of the Surf and Sand at 1555 South Coast Highway. Motion: Kollenda. Second: Ervin Yeas: Ballard, Chauvel, Ervin, Kollenda, Schwerner, Smith. Noes: None. Staff Poeschl stated the item will go to the City Council for approval.

- C. Main Beach Renovation Thomas Perez, Assistant Director of Public Works, presented the staff report on the item regarding removal of two existing bike racks at Main Beach and replacing them with eight circular stainless steel bicycle racks. The original project was approved with the condition that the Public Works Department presents a request for artist-designed racks to the Arts Commission for their consideration. Discussion ensued regarding the design of the alternate racks and high cost. A motion was made to instruct the Public Works Department proceed with the installation of the bicycle racks at Main Beach in accordance with their original design as described and recommended the required Art in Public Places funds of \$13,125 be allocated to the Art-in-Lieu Fund for a future project. Motion: Schwerner. Second: Kollenda. Yeas: Ballard, Chauvel, Ervin, Kollenda, Schwerner, Smith. Noes: None
- D. <u>Sub-Committee Assignments</u> Staff Poeschl provided a list of the established Arts Commission sub-committees, their members, and staff liaisons. Discussion ensued regarding the current list and possible elimination of some sub-committees that are no longer required or useful. Title: Laguna Art Museum 2024 Art in Nature

Location: Main Beach and Heisler Park

Overview

The Laguna Art Museum (Museum) has been presenting "Art In Nature" since 2012 with temporary art installations at Main Beach Park. This year the Museum is proposing a sculpture installation by Christian Sampson titled "Ocean Ions". Mr. Sampson is a multidisciplinary artist whose work hovers between painting and sculpture. He creates layered installations of acrylic with a dichroic coating on sculptures which result in "solar paintings" and evoke a multisensory experience. Having earned an MFA from Hunter College, NYC, his works have been exhibited at the Centre Georges Pompidou, Paris, FR, the Museum of Fine Arts, St. Petersburg, FL, and The Turn Gallery, NYC, among many others. He lives and works in Los Angeles and Sarasota, Florida.

The installation will consist of five sculptures, each a grouping four or five circular intersecting disks or rectangular intersecting squares ranging in size from 2'x2' to 3'x3' in diameter for a total of 8' in diameter per site. They are made from Solyx colored acrylic transparent films on Optix plexiglass. They will be installed and de-installed daily from November 7 through November 11, 2024 by Museum staff and overseen each day by volunteer docents. The exact placements are noted in the included proposal: three in Heisler Park and two on the sand at Main Beach. If needed, the sculptures will be secured in the sand with garden stakes or set on mounting stands in the Heisler Park grass areas.

There is a proposed public Dance Concert from 4pm to 4:30 on Saturday, November 9, 2024, on Main Beach with two acoustic musicians (flute and harmonium). A rehearsal will take place on October 30, 2024 on the beach (north of Main Beach underneath the Gazebo area), with beach access needed from 2:30pm to 7pm. The dance company, The Votive Collective, will provide six to eight dancers for the performance. The Museum will obtain a film permit to film the performance via a licensed drone operator.

The Cultural Arts Department is working with the Museum and several City Departments on behalf of the Museum to assist with planning and communication including Public Works, Marine Safety, Community Development, and the Communications Departments. The Museum will be in contact with Marine Safety regarding weather conditions and shifting sand in the weeks prior to the installation. The required insurance has been provided for the City by the Museum, who will also apply for a Temporary Use Permit for the installations.

Recommendation:

The Public Art Sub-Committee consisting of Commissioners Adam Schwerner, Donna Ballard and Pat Kollenda has reviewed the application and is recommending approval as presented. The action required is for the Arts Commission to recommend the City Council approve the proposal submitted by the Laguna Art Museum for the temporary installation of "Ocean Ions" by Christian Sampson from November 7 through 11, 2024 to include a dance performance on November 11, 2024 at Main Beach and Heisler Parks.

ARTISTS STATEMENT

My artwork explores ideas of the projection and reflection of light and color. Blending cutting-edge

technologies in glass and plastics with philosophies ranging from the California Light and Space

movement of the 1960s to the optical explorations of pre-cinematic 19th-century animators to the

spiritual abstract painting of the early 20th century, I seek to create light-based installations that

transform site-specific spaces into living, interactive artworks. I'm also very interested in engaging the

public with the artworks to expand their reach and further activate each work by including

performances, 'zines, yoga, and other community engagement initiatives within my practice.

My outdoor site-specific sculptural installations for the city of Laguna Beach will be film and acrylic

forms animated by sunlight, the natural landscape and the viewer. The objects will create durational

light projections during the course of the day, changing from hour to hour like a large color

Kaleidoscopic sundial. The viewer will encounter playful projections and reflections of color and form

that utilize the natural beauty of the landscape - harnessing natural light as an artmaking material and

art form. My goal as an artist is to create 4-dimensional light-based works in Laguna Beach that

capture beauty and "awe" using the light of this magical location.

A dance performance featuring light will accompany my sculptural installations and involve a dance

troupe choreographed to feature dancers activating the sculptures in the golden hour/sunset as a

human kaleidoscope on Laguna Beach. The dance performance will be comprised of form, color and

movement projected and reflected on the sands of the beach. Visitors and the Laguna Beach

community will experience these animations in real-time with movements of color, form, projections,

reflections and shadows. A play of color and light. Once the performance is finished, all sculptures will

return to the Laguna Art Museum to go on display and only footprints will be left on the beach.

Five sculptural installations made of acrylic and colored film will be displayed Thursday, November 7, through

Monday, November 11, 2024, throughout Main Beach and Heisler Park. Each work is an installation that reflects

and projects colored light using the sun's rays to create a multidimensional experience. The time-based durational

element will change depending on the sun's path, time of day, and perspective of the viewer. The Museum will

bring the works out and in each day with nothing staying outdoors overnight. The sculptures will be constantly

"staffed" with Museum staff and volunteer docents.

feature free admission to the museum.







OCEAN IONS - PERFORMANCE

PERFORMANCE

Elegant spatial beach performance of light, color, form and sound. The performance will include dance movements by 6-8 dancers from LA's Volta Collective, using light, color, and acoustic music to slow down time and captivate viewers. The light paintings are projected onto the beach and dancers. They are created using only colored acrylic discs and the sun's rays. Dancers' costumes and capes, painted by Ariel Dill, will spin with rule-based, minimal dance movements as colors bounce, forming a human kaleidoscope. Each gesture of light, color, sound, and movement invites viewers to a multi-sensory experience of the now – a present-time loop of shadows and colored sunlight activating and animating the dancers while the dancers activate and animate the beach. LAM estimates about 600 people to be in attendance. No electricity of any kind is required. Note that the Dancer's capes will be constructed of natural fiber fabric (cotton or silk) and painted on with acrylic.

CROWD CONTROL

The area will be staffed by LAM employees and volunteers who can discuss the area and the performance with beachgoers. Starting at 3:00 p.m., additional LAM staff and volunteers will be placed throughout Main Beach to direct people to the performance area. They will remain in place throughout the performance and until approximately 7:00 p.m. to ensure the safe departure of all performance attendees.

Similar procedures will be followed for the dress rehearsal on 10/30. This dress rehearsal is not intended as a public performance but rather a true rehearsal and video documentation opportunity. LAM staff and volunteers will be on-site and stationed in the surrounding areas to discourage large crowds from gathering and sharing information about the actual performance on 11/9. The Museum will not promote the dress rehearsal, and it will not be mentioned in any official communications to the media, on the museum's website, etc.

PERFORMANCE DOCUMENTATION

LAM will apply for a film permit from Community Services and any needed drone-related permits. Several photographers (including a professional, fully permitted drone operator) will document the dress rehearsal and performance via photo and video on the days of the performance. The video of the performance will be presented in an exhibition of Christian Sampson's work at Laguna Art Museum from 11/7/2024 through early March 2025.

ENVIRONMENTAL IMPACT OF OUTDOOR PERFORMANCE

All materials used during the performance will be returned to the Museum on the same day of the performance, leaving no refuse. LAM staff will ensure that both the dress rehearsal and performance day sites are left free of trash from Museum and artistic personnel and spectators.

PERSONNEL

For Performance: dancers, musicians, event coordinator(s) from Museum, event coordinator for Christian (Annie Wharton), videographers, Museum volunteers, photographer(s). The performance will be choreographed and presented by the Volta Collective. Directed by Mamie Green, Volta fuses physicality, theatricality and multidisciplinary approaches to performance. Volta is passionate about presenting dance in accessible, nontraditional spaces, often collaborating with artists

across mediums. Volta's work has been presented in the US, abroad, and dance festivals and has been reviewed by such publications as the *LA Times*.







Title: Activation of Public Art Mural "Super Natural Bloom" by Dabsmyla

Location: Alta Laguna Park, 3300 Alta Laguna Blvd.

Overview

The Art Commission approved the installation of the Public Art Mural "Super Natural Bloom" by Dabsmyla in Alta Laguna Park which was installed in August 2023. The mural is located on a block wall in front of the baseball diamond and across from the pickle ball courts (photo below). An activation at the site of the mural is proposed as an outreach activity to invite the public to view the art for the first time and/or from a new perspective, and as a form of documentation. The proposed activation is a dance performance choreographed by Jodie Gates.

The dance will be a duet of three to five minutes in length. It will be performed twice; the first to be videotaped for viewing on the city's website, followed by an afternoon performance free to the public. Jodie Gates will incorporate the live audio landscape of pickle ball, families and children laughing, baseball, tennis, dogs, etc., as the background of a playful and joyful duet between three and five minutes long. In post-production, this background will be mixed to music for the video. One public performance and one video will be produced as part of the proposed project.

The dance will be rehearsed in an available studio at the City Community Center between September 14-22, 2024 and will be performed on a date mutually agreed upon in September or October, 2024. The budget for the activation will be \$5,000.

Recommendation:

The Public Art Sub-Committee consisting of Commissioners Adam Schwerner, Donna Ballard and Pat Kollenda has reviewed the application and is recommending approval as presented.

The Art of Play

Proposed Project:

A site-specific dance work to be performed at the Dabsmyla Mural free for the public and videoed for future viewings. In addition to the public showing, the duet will be videoed without a viewing audience, and our professional videographer (Aron Cota) will edit the visual with audio for future viewings.

Concept:

Choreography by Jodie Gates for a site-specific dance work to be performed at the Dabsmyla Mural. A playful duet, late afternoon when people are playing and walking in the park (between 4:00p-5:30p). Dancers begin in the two storage "houses" to the left of the mural. At the beginning of the duet, the audio landscape will represent all the joy and community the park creates through sound (pickle ball, families and children laughing, baseball, tennis, dogs etc.). This audio will serve as the background to begin the playful duet which will then be mixed with our song for the duet to be danced in front of the mural. One live showing and one video will be produced with the funds received. The duet will be between 3 – 5 minutes in length.

Timeline:

September 14 – 22, 2024 – Studio Rehearsal

September 22 or 28. Optional dates are October 12 or 13, 2024 – Site Showing and Video

Budget:

- \$1500.00 choreographic fee including concept, rehearsals at the city dance studio or Laguna Beach High School Dance Studio, 1-day shoot, and post video supervision.
- \$2000.00 \$1000.00 per dancer for rehearsal, performance at site and video shoot (2 dancers).
- \$1,000.00 Videographer Aron Cota (1 day shoot with 2 cameras, video editing including post with audio).
- \$250.00 Costumes, props, and audio/speakers for dancers.
- \$250.00 Audio soundscape recording from park play (baseball, tennis, pickleball, talking etc.).

TOTAL BUDGET: \$5,000.00

Title: Promenade of Forest Temporary Installation

Location: 295 Forest Avenue, Laguna Beach

Overview

The Stage on Forest is located at the corner of Forest Avenue and Glenneyre Street, a retail area with numerous restaurants and boutique businesses located near Main Beach. The stage is utilized for live music performances on Friday, Saturday, and Sunday evenings. The City issued a call for artists to design a temporary art installation or mural with the theme of "Marine Sanctuary" to occupy the Stage on Forest for up to three months or based on condition, with an honorarium of \$5,000.

Summary of the Matter

Three finalists were invited to present concepts to the Arts Commission on April 22, 2024. The Commission selected the proposal by Brooks Atwood for an interactive digital stage floor. Cultural Arts staff met with the artist on site to review details of the installation. Mr. Atwood proposed changes to address the concerns of staff and the artist, which included safety, electricity usage, outdoor storage of computer components, and disability access. The proposed revisions were presented to the sub-committee, which deemed the changes significant enough to warrant reopening of the selection process, allowing the other finalists to revise and present their new proposals to the Arts Commission, as well.

Artists were given a deadline of July 1, 2024, to submit revised proposals for consideration. Artist finalists Sara Dehghan and Amy Rose Hammond submitted revised proposals. Mr. Atwood declined to pursue the project further.

Recommendation

It is recommended the Arts Commission hear the presentations from artists Sara Dehghan and Amy Rose Hammond and select a proposal for installation or deny all proposals and conclude the opportunity. The Commission should also direct staff to establish an exhibition period of up to three months with respect to the fabrication and installation timeline of the work and the durability of installation materials.




