SUBJECT: Call for Artists – Artistic Innovation Grants for Artists (Item 6A)

On February 13, 2023, the Arts Commission approved the allocation of \$40,000 to augment a fund balance of \$10,000 to the 2023/24 Arts Commission Special Programs budget of the Laguna Beach Marketing Tourism District offering a grant opportunity to individual artists. The budget was approved by the City Council in June 2023. The fund balance was from funding allocated to artists during COVID provided through the Wayne Peterson Trust of the Laguna Beach Community Foundation. Grants were provided to 28 artists during 2020. The Commission approved continuing with individual grants to artists for innovation to encourage experimentation, a goal which was identified in the Cultural Arts Plan. In 2023, the Commission allocated \$40,000 to three artists to implement their proposals.

The Arts Commission has carry-over funds available in its budget from savings in programming and the difference in the estimated and actual collected funds budgeted for the Laguna Beach Marketing and Tourism District. There is an available budget of \$270,000 which does not include savings dedicated to funding a larger project or capital campaign. In addition, there are available funds of \$16,975 unallocated during the granting cycle. The subcommittee consisting of Donna Ballard, Adam Schwerner and Michael Ervin are recommending a total available Program budget of \$100,000 be allocated to the Artistic Innovation Grant for Artists, \$16,975 in available funds augmented by \$84,000 in savings. The remaining \$975 would cover costs of on-line submissions and increased marketing efforts.

Staff meet with the sub-committee to review draft guidelines. The sub-committee provided the following direction:

- Identify artists tiers (Emerging \$5,000 \$10,000, Mid-Career \$10,000- \$20,000 and Established \$20,000 to \$30,000)
- Open to artists residing, working, or exhibiting in Laguna Beach.
- Artists must premier the work/project and provide an overview of expenditures.
- Outlined selection process.
- Present a report at the Arts Commission meeting at the collusion of the grant.

The revised Call for Artists is included as an attachment and submissions would be accepted by January 10, 2025 with distribution anticipated by early March. Artists will have 24 months to facilitate their proposal. The opportunity will be noticed via the City's digital newsletters, an advertisement in Stu News and California Arts Council website.

Recommendation: The Innovation Grant sub-committee is recommending approval of the Call for Artists – Artistic Innovation Grants for Artists as presented.

CALL FOR ARTISTS DRAFT 9/17/2024 ARTISTIC INNOVATION GRANTS FOR ARTISTS Creating, Exploring and Implementing New Ideas

The City Council and Arts Commission recognizes and supports artists who push the boundaries of creative expression, anchor our Laguna Beach community, and advance the creative field. The Artistic Innovation Grants for Artists encourages the spirit of experimentation and exploration, exclusively engaging artists in Laguna Beach.

This grant program offers grants between \$5,000 and \$20,000 to support the art-making process and premiere of these endeavors. This program has been made possible through the generous support of the lodging establishments and City of Laguna Beach.

An Artistic Innovation Grant for Artists project is one that has in-person experiences of art, art making, or artists at the heart of the initiative and introduces a new or original idea or product to the applicants audience. Engagement through feature presentation and outreach included but is not limited to performance, publication, lecture/demonstration, exhibition, masterclass and/or workshop.

Applications will be accepted January 10, 2025 for project occurring between April 1, 2025 and April 1, 2027. Awards will be reviewed by the Arts Commission on March 10, 2025 and awards announced March 17, 2025 (these dates are subject to change.) Each applicant may submit one application. At the conclusion of the program grant recipients will be required to provide an overview of expenditures and brief description of the project undertaken and present to the Arts Commission at its regularly held meetings.

These grants aim to support artists holistically to build a more equitable Laguna Beach Arts ecosystem. By pushing the boundaries of creativity and expression Artists contribute to the evolution of culture and human understanding.

DEADLINE: January 10, 2025

ELIGIBILITY: Open to Emerging, Mid-Career and Established Artist who reside, work, or exhibit in Laguna Beach. Applicants must be 18 years and older by the application due date. Proof of eligibility will be required. Demonstrate through a professional resume detail of engagement in a creative practice prior to the application due date.

Conflict of Interest: City of Laguna Beach employees, members of City Boards or Commissions are in-eligible for this program.

HONORARIUMS

Emerging Artists - \$5,000 - \$10,000

Emerging artists are those in the beginning stages of making their work public and engaging the larger community in their practice. Individuals in this tier may have had a few public showings of their work but have demonstrated potential and vision with a strong commitment to artistic growth.

Mid-Career Artists - \$10,000 - \$20,000

Artists in this tier regularly make their work public and engage the larger community in their practice. Artists will have had several years of experience, demonstrated public engagement and have a clear impact of the proposed project on career development.

Established Artists \$20,000 - \$30,000

Artists in this tier can identify a significant body of work, produced over a substantial period, that has engaged their communities and that has made a significant social impact. Artists must demonstrate artistic excellence, and their project make wide-reaching cultural and community impact.

- Artists may apply in one career tier only.
- The judging panel may alter the applicants tier during the review process if believed based on submitted applications a reclassification is applicable.

- Proof of eligibility and professional resume
- Grant application tier submission and request amount
- Proposal Title
- Overview of the project (300 words)
- Objectives of the project (500 words)
- Project implementation
- Timeline

SELECTION PROCESS

The Arts Commission will review the applications and make their selection based on the following:

- Proposal design, appropriate budget, clear artistic based objective, unique artistic vision and ability to implement the project as demonstrated by resume and supporting documents.
- Proposal impact and engagement with the Laguna Beach community.
- Quality and professionalism of the work that enhance the public's experience and enhance the City's cultural profile.
- Appropriateness and relevance and should not contradict the City's values of environmental sustainability, accessibility, and cultural inclusiveness.
- Adherence to submission requirements.
- Diversity of artists and artistic styles.

Applications first reviewed by the Arts Commissions Sub-Committee. If the proposal is approved by the subcommittee the item will be placed on the agenda for the full Arts Commission. The Arts Commission will meet on March 10, 2025 to review the recommendations at 5 p.m. in the City Council Chamber, 505 Forest Avenue, Laguna Beach.

The City of Laguna Beach does not provide any additional resources to the grant honorarium, and does not provide marketing, publicity, venue rental or reservation. The selected recipient will enter a contract with the City of Laguna Beach to undertake the project. Artists must keep the Cultural Arts Department updated on progress and identify the funding as the "Innovation Grants for Artists funded by the lodging establishments and City of Laguna Beach". At the conclusion of the granted program a presentation will be made to the Arts Commission at its regularly scheduled meeting.

EXAMPLE OF OVERVIEW OF PROJECT IN 300 WORDS
